 people? Make sure you support your position with reasons, explanations, and
 examples.

- 6. Some people believe that one should always be honest and truthful, while others believe that under certain circumstances it is acceptable to be dishonest or not tell the truth. Is lying ever permissible? Make sure you support your position with reasons, explanations, and examples.
- 7. In the business world some managers encourage individual competition among employees, while others promote collaboration and teamwork. Which do you think is a more effective strategy? Make sure you support your position with reasons, explanations, and examples.
- 8. We see cell/mobile phones almost everywhere, from cars and buses to restaurants and classrooms. Many people argue that cell/mobile phones have become a necessary part of modern life and, as such, should be unrestricted. Others argue, however, that they can be disruptive and thus there should be limitations on their use. Should there be regulations limiting the use of cell/mobile phones?
